Swimmers may enter a maximum of 8 individual events during the entire meet and no more than 3 individual events per day. Disability Swimmers	PVS and host clubs along with their Meet Directors are committed to the Inclusion Policy as adopted by the Board of Directors. Athletes with disabilities are welcome to participate, and are asked to provide advance notice of desired accommodations to the Meet Director. The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.
Warm Up	The prescribed Potomac Valley Swimming warm-up procedures and safety policies will be followed. The meet director may determine the structure of the warm-up, including times and lane assignments.
Supervision	<p>Coaches are responsible for the conduct of their swimmers and families, as well as maintaining clean team areas. Coaches &amp; deck officials are required to display their valid 2011 USA Swimming credentials.</p> <p>Coaches are responsible for ensuring that their team areas are clean of any debris at the conclusion of each meet session.</p> <p>Swimmers in the meet, unaccompanied by a USA-S coach must be certified by a USA-S coach as proficient in performing a racing start or must start each race from within the water. Ensuring compliance is the responsibility of the swimmer or the swimmer's legal guardian.</p>

Include contact information (e-mail, phone, officials contact).</p> <p><b>Entry Deadline: Tuesday, October 11<sup>th</sup> by 5pm</b></p> <p><b>Important:</b></p> <p>The Meet Director will acknowledge receipt by return email within 24 hours. Teams submitting entries that do NOT receive an acknowledgement should contact the Meet Director by other means to confirm receipt.</p> <p>The above date is the deadline for teams to submit their entries to the Meet Director.
