**Officials:** Certified officials wishing to work the meet should contact Izumi Horikawa at <a href="https://horikawa@comcast.net">horikawa@comcast.net</a>. Any trainees must contact Izumi at least one week in advance to book a training spot.

Clubs will be responsible for providing their fair share of timers, and will be assigned lanes by the meet director. There will be no electronic timing at this meet; watch times only. Each lane MUST have 3 timers at all times, no exceptions.

**Location:** Kennedy Shriver Aquatic Center, (Formerly the Montgomery Aquatic Center) 5900 Executive Boulevard, N. Bethesda, MD 20852 (240) 777-8070

- 8 lane, 25 yard pool with continuous flow-through gutters and non-turbulent lane dividers. The measurement for MAC in the fixed wall configuration is 25 yards but is not certified.
- There is no separate warm up/cool down pool.
- The competition course has not been certified in accordance with USA Swimming Rules and Regulations Article 104.2.2, which is measured in length prior to the start of the meet.
- Water depth is 18' at the starting end of the pool and 6'6" at the turning end of the pool.

**Warm-Up Procedures:** The prescribed Potomac Valley Swimming warm-up procedures and safety policies will be followed.

**Eligibility:** This meet is open to invited United States Swimming Athletes of the following clubs: FAST, FISH, JFD, TIBU, Team Tollefson and RMSC. Swimmers will compete at the age attained on the first day of the meet. It may be necessary to limit entries due to the time constraints. No on-deck USAS registration is permitted.

PVS and host clubs along with their Meet Directors are committed to the Inclusion Policy as adopted by the BOD. Athletes with a disability are welcomed and are asked to provide advance notice of desired accommodations to the Meet Director. The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.

**Meet Format:** Seed times are short course yards. The meet will be seeded as mixed events. All swimmers will be split into a boys team and a girls team regardless of USAS affiliation.

**Rules:** Current USA Swimming rules will govern this meet. All events are timed finals. A contestant may enter no more than three individual events per day, and no more than six individual events for the meet.

The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for the 12 &U sessions in Rule 205.3.1F.

In compliance with USA Swimming Rules and Regulations; the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms or locker rooms. As per PVS policy; the use of equipment capable of taking pictures (i.e. cell phones, cameras, PDA's etc) are banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

The practice of deck changing is prohibited at all PVS Sanctioned events. Swimmers participating in deck changing would be violating the USA Swimming Sportsmanship policy.

**Deck Access:** All PVS/USAS registered coaches and deck officials are required to wear current 2012 USA Swimming membership credentials on the deck area. Anyone not displaying proper credentials will be asked to leave the deck area. **Parents not working the meet as a deck official, volunteer lane timer, or other meet position are not permitted on deck.** 

**Warning:** Any club that enters an unregistered athlete, falsifies an entry in any way, or permits an unregistered coach to represent them, will be fined the sum of \$100.00, and no further entries will be accepted from the club until the said fine is paid. All swimmers, coaches and officials must be properly registered with USA Swimming for 2012.

#### **Entry Information:**

- Entry Fees: \$5.50 per individual event.
- Regular Entry Deadline: Tuesday, February 7, 2012 at 11:59 PM.
- Late entries and deck entries will not be accepted.
- Deck entries will be accepted provided there is an empty lane available. A new heat will not be created.
- Swimmers must show their 2012 USAS Athlete registration card.
- Deck Entry Fee: \$10.00 per individual event, due at time of acceptance.
- No on-deck USAS registration permitted.

#### **Electronic Entry Procedures:**

- Email must include reports by name and by event. Include total number of swimmers and total number of events, along with contact information (name, phone number, e-mail) of a club representative in the body of the e-mail.

- Each club is requested to remit one check to cover the entry fees of the entire team. Please do not send cash. Entry Fees are due with entries.

**Scoring:** The meet will be scored as follows: 20, 17, 16, 15, 14, 13, 12, 11, 9, 7, 6, 5, 4, 3, 2, 1.

**Awards:** Awards will be given for  $1^{st} - 16^{th}$  place. Gender team champions will all receive an award at the conclusion of the meet.

**Spectator Admission and Heat Sheets:** There will be no charge for admission. Programs will be available for sale.

**Concessions:** A small concession will be offered and as well as hospitality for coaches/officials.

#### **Swim Center Rules and Conduct**

At the request of Montgomery County Recreation Department, swimmers are not to leave the pool deck without appropriate attire. Coaches will be responsible for the conduct of their athletes while in the facility and surrounding grounds. Failure to follow these rules or any inappropriate behavior will result in the athlete being barred from further competition in the meet. Parents will be responsible for the conduct of any minor children that accompany them.

- No glass containers are permitted within the facility.
- Swimmers must be in direct contact with their supervising coach before they will be allowed to enter the pool for warm-up.
- No camera cell phones are permitted in the locker rooms.

#### **Special Note**

In granting this sanction it is understood and agreed that USA Swimming, Potomac Valley Swimming, Kennedy Shriver Aquatic Center, Rockville Montgomery Swim Club and the Montgomery County Rec Department shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
