**Officials:** Certified officials and trainees wishing to work the meet should contact Scott at least one week in advance.

Clubs will be responsible for providing their fair share of timers, and will be assigned lanes by the meet director. **There will be no electronic timing at this meet; watch times only.** Each lane MUST have 3 timers at all times, no exceptions.

**Location:** Olney Swim Center, 16605 Georgia Avenue, Olney, MD 20832 (240) 777-4995

- 8 lane, 25 yard pool with separate area for warm up/cool down, continuous flow-through gutters, and non-turbulent lane dividers. Diving is not permitted in the warm up/cool down area.
- Water depth is 14'at the starting end and 4'5" at the turn (bulk head) end of the pool.
- The competition course has not been certified in accordance with USA Swimming Rules and Regulations Article 104.2.2(C), because it is a bulkhead pool, which is measured in length prior to the start of the meet.

**Warm-Up Procedures:** The prescribed Potomac Valley Swimming warm-up procedures and safety policies will be followed. The Meet Director may determine the structure of the warm-up, including times and lane assignments.

**Eligibility:** Open to all USA Swimming registered athletes. Athletes shall compete at the age attained on the first day of the meet.

PVS and host clubs along with their Meet Directors are committed to the Inclusion Policy as adopted by the BOD. Athletes with a disability are welcomed and are asked to provide advance notice of desired accommodations to the Meet Director. The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.

**Rules:** Current USA Swimming rules will govern this meet. A contestant may enter no more than three individual events per day. All events will be timed finals. No on-deck USAS registration permitted.

The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for the 12 &U sessions in Rule 205.3.1F.

In compliance with USA Swimming Rules and Regulations; the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms or locker rooms. As per PVS policy; the use of equipment capable of taking pictures (i.e. cell phones, cameras, PDA's etc) are banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

The practice of deck changing is prohibited at all PVS Sanctioned events. Swimmers participating in deck changing would be violating the USA Swimming Sportsmanship policy.

**Deck Access:** All PVS/USAS registered coaches and deck officials are required to wear current 2012 USA Swimming membership credentials on the deck area. Anyone not displaying proper credentials will be asked to leave the deck area. **Parents not working the meet as a deck official, volunteer lane timer, or other meet position are not permitted on deck.** 

**Warning:** Any club that enters an unregistered athlete, falsifies an entry in any way, or permits an unregistered coach to represent them, will be fined the sum of \$100.00, and no further entries will be accepted from the club until the said fine is paid. All swimmers, coaches and officials must be properly registered with USA Swimming for 2012. Entry fees are due with meet entry. Unpaid fees will be reported to the PVS Administrative Office at the conclusion of the meet.

### **Entry Information:**

- Entry Fees: \$6.00 per individual event, \$12.00 per relay event.
- Entry Deadline: Tuesday, February 28, 2012 at 11:59 PM.
- No late entries will be accepted.
- Deck entries will be accepted provided there is an empty lane available. A new heat will not be created.
- Swimmers must show their 2012 USAS Athlete registration card.
- Deck Entry Fee: \$10.00 per individual event, due at time of acceptance.
- No on-deck USAS registration permitted.
- Meet Directors are requested to acknowledge receipt by return e-mail within 24 hours. Clubs submitting entries that do NOT receive an acknowledgement should contact the Meet Director by other than e-mail to confirm receipt.

### **Electronic Entry Procedures:**

**Awards**: Medals will be awarded for all individual events, first through eighth place and first through third place for relays. Ribbons will be awarded for ninth to sixteenth place individual. Team trophies will be awarded to the top three scoring teams at the conclusion of the meet.

**Spectator Admission and Heat Sheets:** There will be no charge for admission. A boy's session and girl's session program will be available for purchase.

#### **Swim Center Rules and Conduct**

At the request of Montgomery County Recreation Department, swimmers are not to leave the pool deck without appropriate attire. Coaches will be responsible for the conduct of their athletes while in the facility and surrounding grounds. Failure to follow these rules or any inappropriate behavior will result in the athlete being barred from further competition in the meet. Parents will be responsible for the conduct of any minor children that accompany them.

- No glass containers are permitted within the facility.
- Swimmers must be in direct contact with their supervising coach before they will be allowed to enter the pool for warm-up.
- No camera cell phones are permitted in the locker rooms.

### **Special Note**

In granting this sanction it is understood and agreed that USA Swimming, Potomac Valley Swimming, Olney Swim Center, Rockville Montgomery Swim Club and the Montgomery County Rec Department shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
