Eligibility:	Open to all Potomac Valley Swimmers Registered as USA Swimming Athletes ages 8 & Under who are Registered USA Swimming Athletes. All athletes shall compete at the age attained on the first day of the meet.

	Current USA Swimming rules shall govern the meet.				
	All events are timed finals. All events will be swum slowest to fastest. A contestant may enter no more than three (3) individual events per day.				
	In compliance with USA Swimming Rules and Regulations, the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms or locker rooms. As per PVS policy; the use of equipment capable of taking pictures (i.e. cell phones, cameras, PDA's etc) are banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.				
Rules:	Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited.				
	Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. (this statement can either be under RULES or SUPERVISION).				
	The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for sessions that include 12 & U events per Rule 205.3.1F.
