Clubs are responsible for providing their fair share of timers, and required number of timers will be assigned by the meet director. <u>There will be no electronic timing at this meet; watch times only.</u> Each lane MUST have 3 timers at all times, no exceptions.

Location: Olney Swim Center, 16605 Georgia Avenue, Olney, MD 20832 (240) 777-4995

- 8 lane, 25 yard pool with separate area for warm up/cool down, continuous flow-through gutters, and nonturbulent lane dividers. Diving is not permitted in the warm up/cool down area.
- Water depth is 14' at the starting end and 4'5" at the turn (bulk head) end of the pool.
- The competition course has not been certified in accordance with USA Swimming Rules and Regulations Article 104.2.2(C), because it is a bulkhead pool, which is measured in length prior to the start of the meet.
- Manual timing (stopwatches only) will be used for this meet for events of 25 yards.
- Colorado Electronic Timing System, touch pads, horn start.
- Semi-Automatic timing (push buttons) will be used for this meet for events of 50 yards or longer.

Meet Schedule:

- Warm-ups: 7:00 8:00 AM
- Event Start: 8:10 AM

Warm-Up Procedures: The prescribed Potomac Valley Swimming warm-up procedures and safety policies will be followed.

Deck Access: All PVS/USAS registered coaches and deck officials are required to show current 2016/2017 USA Swimming membership credentials on the deck area. **Parents not working the meet as a deck official, volunteer timers, or other meet position are not permitted on deck.**

Eligibility: This meet is open to <u>invited</u> PVS athletes/teams and <u>invited</u> USA Swimming athletes/teams. Swimmers will compete at the age attained on the first day of the meet. It may be necessary to limit entries due to the time constraints. No on-deck USAS registration permitted.

PVS and host clubs along with their Meet Directors are committed to the Inclusion Policy as adopted by the BOD. Athletes with a disability are welcomed and are asked to provide advance notice of desired accommodations to the Meet Director. The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition

Rules: Current USA Swimming rules will govern this meet. All events are timed finals. A contestant may enter no more than three individual events per day and no more than five individual events for the meet. **The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for the 12 &U sessions in Rule 205.3.1F.**

In compliance with USA Swimming Rules and Regulations; the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms or locker rooms. As per PVS policy; the use of equipment capable of taking pictures (i.e. cell phones, cameras, PDA's etc) are banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Changing into or out of swimsuits other than in locker rooms or other designated area is prohibited.

Warning: Any club that enters an unregistered athlete, falsifies an entry in any way, or permits an unregistered coach to represent them, will be fined the sum of \$100.00, and no further entries will be accepted from the club until the said fine is paid. All swimmers, coaches and officials must be properly registered with USA Swimming for 2016/2017.

Entry Information:

- Entry Fees: \$4.50 per individual event.
- Entry Deadline: Tuesday, November 1, 2016 at 11:59 PM.
- No late entries will be accepted.
- No on-deck USAS registration permitted.
- Meet Directors are requested to acknowledge receipt by return e-mail within 24 hours. Clubs submitting entries that do NOT receive an acknowledgement should contact the Meet Director by other than e-mail to confirm receipt.

Entry Procedures:

Swim Center Rules and Conduct
