Clubs are responsible for providing their fair share of timers, and required number of timers will be assigned by the meet director. Each lane MUST have 3 timers at all times, no exceptions.

- 8 lane, 25 yard pool with continuous flow-through gutters and non-turbulent lane dividers.
- The competition course has not been certified in accordance with USA Swimming Rules and Regulations Article 104.2.2(C).
- Water depth is 18' at the starting end of the pool and 6'6" at the turning end of the pool.
- There is no separate warm up/cool down pool.
- Colorado Electronic Timing System, horn start.
- Manual timing (stopwatches) will be used for this meet for 25 yard events.
- Semi-Automatic timing (push buttons) may be used for this meet for events of 50 yards or longer.

Meet Schedule:

- Warm-ups: 9:00 – 9:40 AM
- Event Start: 9:45 AM

Warm-Up Procedures: The prescribed Potomac Valley Swimming warm-up procedures and safety policies will be followed.

Deck Access: All PVS/USAS registered coaches and deck officials are required to show current 2019 USA Swimming membership credentials on the deck area. Anyone not displaying proper credentials will be asked to leave the deck area. **Parents not working the meet as a deck official, volunteer timers, or other meet position are not permitted on deck.**

Eligibility: This meet is open to **invited** PVS athletes/teams and **invited** USA Swimming athletes/teams. Interested teams should email the Meet Director for an invitation as space is limited. Swimmers will compete at the age attained on the first day of the meet. It may be necessary to limit entries due to the time constraints.

PVS and host clubs along with their Meet Directors are committed to the [Inclusion Policy as adopted by the BOD](#). Athletes with a disability are welcomed and are asked to provide advance notice of desired accommodations to the Meet Director. The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition.

Meet Format:

- Seed times are short course yards.
- The meet will be seeded as mixed events.
- All swimmers will be split into a boys team and a girls team regardless of USAS affiliation.

Rules:

- Current USA Swimming rules will govern this meet.
- No on-deck USAS registration is permitted.
- All events are timed finals.
- A contestant may enter no more than three individual events per day, and no more than six individual events for the meet.

No personal chairs allowed on deck for swimmers.

The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for sessions that include 12 & U events per Rule 205.3.1F.

In compliance with USA Swimming Rules and Regulations: the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms or locker rooms. As per PVS policy: the use of equipment capable of taking pictures (i.e. cell phones, cameras) is banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Deck changes are prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Scoring: The meet will be scored as follows: 20, 17, 16, 15, 14, 13, 12, 11, 9, 7, 6, 5, 4, 3, 2, 1.

Awards: Awards will be given for 1st – 16th place. Gender team champions will all receive an award at the conclusion of the meet.

Concessions: A small concession will be offered and as well as hospitality for coaches/officials.

Warning: Any club that enters an unregistered athlete, falsifies an entry in any way, or permits an unregistered coach to represent them, will be fined the sum of \$100.00, and no further entries will be accepted from the club until the said fine is paid. All swimmers, coaches and officials must be properly registered with USA Swimming for 2019.

Entry Information:

- Entry Fees: \$7.00 per individual event.
- Entry Deadline: Tuesday, January 22, 2019 at 8:00 PM.
- Late entries will not be accepted.

Swim Center Rules and Conduct

At the request of [Montgomery County Recreation](#), swimmers are not to leave the pool deck without appropriate attire. Coaches will be responsible for the conduct of their athletes while in the facility and surrounding grounds. Failure to follow these rules or any inappropriate behavior will result in the athlete being barred from further competition in the meet. Parents will be responsible for the conduct of any minor children that accompany them.

- No glass containers are permitted within the facility.
- Swimmers must be in direct contact with their supervising coach before they will be allowed to enter the pool for warm-up.
- No camera cell phones are permitted in the locker rooms.

Special Note

In granting this sanction it is understood and agreed that USA Swimming, Potomac Valley Swimming, Kennedy Shriver Aquatic Center, Rockville Montgomery Swim Club and Montgomery County Recreation shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
