RULES	Current USA Swimming rules shall govern this meet.
	 All applicable adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming <u>Minor Athlete Abuse Prevention Policy</u> ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition.
	No on-deck USA Swimming registration is permitted.
	• In compliance with USA Swimming Rules and Regulations, the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms, or locker rooms. Per PVS policy, the use of equipment capable of taking pictures (e.g., cell phones, cameras, etc.) is banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.
	Deck changes are prohibited.
	• Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
	 Operation of a drone or any other flying devices is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
	Dive-over starts will be used.
	• The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for sessions that include 12 & U events per Rule 205.3.1F.
EVENT RULES	All events are timed finals.
	All events will be pre-seeded except the 1000 Freestyle.
	 Athletes may swim a maximum of six (6) events for the meet and no more than three (3) events per day. No deck entries will be accepted.
POSITIVE CHECK IN	 Positive Check in will be used to seed the Mixed 1000 Freestyle (Event #7).
WARM-UP	 The prescribed PVS warm-up procedures and safety policies will be followed. The Meet Director will determine the structure of warm-up, including times/lane assignments.
SUPERVISION	 Coaches are responsible for the conduct of their swimmers and for cleaning up their team areas. Spectators will be permitted in the facility.
SEEDING	 Standard seeding will be used.
	The 1000 and 500 Freestyle will be seeded Fastest to Slowest.
	• The 1000 Freestyle on Saturday and the 500 Freestyle on Sunday will be flighted. The A flight will swim first, consisting of all 12 & Under swimmers with a NT in the event. The B flight will swim afterwards consisting of all remaining swimmers seeded fastest to slowest. This is to help ensure that we are not exceeding 4 hours for 12 & Under swimmers in the session.

CREDENTIALS	 Parents not working the meet as a deck official, volunteer timer or other position are not permitted on deck. Only athletes, USA Swimming certified coaches, and deck officials will be permitted on the deck. Coaches and Officials should have proof of active USA Swimming membership with them.

	• Officials volunteering for this meet should sign in at the recording table prior to the start of warm-ups. Certified officials who have not previously volunteered should contact the referee upon arrival to make their services available. A comprehensive officials' briefing will precede each session during warm-ups.		
TIMERS	 Participating clubs are requested to provide timers in proportion to their entries. One timer is requested for each 25 entries. 		
	• Two timers per lane. There will be two Head Timers per course.		
	• Swimmers must provide their own timer and counter, if desired, for the 500 and 1000 Free events.		
	An online Timer's Signup will be emailed to participating clubs.		
ENTRY PROCEDURES	Entries should be submitted by email to the Meet Director.		
	• Include in the subject of the email, "IMXPERIENCE Meet - ****" with the club's initials in place of the asterisks. If your club submits multiple entry files include training site in the subject of the email.		
	• Include in entry email: entry file, report of entries by name, report of entries by event.		
	• In the body of your email provide entry numbers (girls, boys, totals), contact information (email, phone, officials contact).		
	Entries directly from individual team members will not be accepted.		
	Entries by phone or fax will not be accepted.		
	• The Meet Director will acknowledge receipt by return email within 24 hours. If acknowledgement is not received in a timely manner, please contact the Meet Director.		
	• Any club that enters an unregistered or improperly registered athlete, falsifies an entry in any way, or permits an unregistered coach to represent them will be fined the sum of \$100 by PVS and no further entries will be accepted from that club until the said fine is paid.
