

Potomac Valley Swimming  
**Competition Committee Report to the BoD**  
From the May 14, 2014 Meeting

- 2014 Summer LC Zones
  - The CCM endorsed the acceptance of Heather Purk, Ethan Gerlach, Jessica Lynn Fry and Chris Schleigel as 2014 LC Zone Assistance Coaches. The Age Group Chair reported that he will fill the remaining two spots and seek acceptance from the Board of Directors at that time.
    - According to the 2014 Winter CCM Minutes, Jessica Lynn Fry was elected as the Assistant Head Coach. So 3 additional assistance coaches will be needed.
    - Action needed: To vote on the acceptance of the three assistant coaches listed above.
- The Competition Schedule for LC 2015 PVS Meets was reviewed, discussed and voted on. There is talk from USA Swimming that 2015 LC Sectionals will be moved and may conflict with our 2015 LC Championship schedule. If after Convention in September the Sectional meet is moved, the PVS Competition Committee will revisit the dates.
  - 2015 LC Champ Schedule
    - LC Age Group Champs – July 9-12, 2015
    - LC Junior Champs – July 16-19, 2015
    - LC Senior Champs – July 16-19, 2015
    - Action – vote to accept these dates for the LC Championship meets
  - 2015 LC Open meet Schedule
    - LC Open 1 – June 14, 2015
    - LC Distance – June 20-21, 2015
    - LC Open 2 – June 28, 2015
    - Action – vote to accept these dates for the LC Open meet schedule.
- The Clubs were given an opportunity to add Club Meets to the 2014-2015 Short Course Schedule. See additional report for all club meets added.
  - Action – To vote on final chance for clubs to add meets to the schedule for September 1-December 31, 2014.
  - Action – To vote on first chance for clubs to add meets to the schedule for January 1-March 31, 2015.
- Scoring PVS Championship meets – It was determined in a previous meeting that PVS Championships will now be scored based upon team size. There will be small teams – up to 75 club members, medium teams – 76-250 members and large team – 251 members or more.
  - No action to be taken
- A motion was brought forth to the CCM to change the policy on when and how both PVS and Club meets are added to the schedule. Currently they are added in a multi-step process during the three Competition Committee Meetings. The proposal is to vote for the full next year's PVS meet schedule, short course and long course, during the Fall CCM, then add all club meets for the full next year's schedule (September 1-August 31) during the Winter CCM. With the ability to make modifications if needed in the spring. The committee endorsed this policy change and recommended that Admin Chair and Sr. Chair work together to finalize the wording for P & P.
  - Action – To vote on the change in policy regarding how and when we add PVS and Club meets to the PVS schedule.
