PVS Officials Committee Report May, 2013

The PVS Officials Committee currently consists of 20 appointed members. The Committee is specifically charged with:

- Recruiting and training officials;
- Planning and conducting the certification program;
- Monitoring and raising the overall quality of officiating;
- Staffing National Certification meets for which PVS is responsible.

Some Important Statistics

- Current number of certified PVS officials 475 (see Appendix 1 for more detail)
- Number of officials clinics held this season (since September, 2012) 28
- Officials Qualifying Meets under the National Certification program (since this time last year) **3**
- **75** PVS officials currently hold National Certification (N2 or N3).
- **48** PVS officials underwent formal evaluation this year under the National Certification program; many officials were evaluated for more than one position, for a total of **68** evaluations this year.
- 5 PVS officials were selected to work National Championship meets during the past year.
- 1 PVS official was selected to work U.S. Olympic Team Trials in 2012.
- 2 PVS officials were selected to work U.S. Paralympic Team Trials in 2012.

Of Note

- After many years of devoted service, Rita Page retired as our Certification Officer. Lynne Gerlach has now assumed this office.
- 14 officials were invited by the Committee this year to start the process for certification as a PVS referee. This is a rigorous process of study, practice, and evaluation; it includes certification in all officiating positions, including timing system and HyTek operator. Seven accepted the Committee's invitation, and most have made significant progress at fulfilling all the requirements.
- 2 PVS officials attended USA Swimming's Officials Workshop in Savannah, GA in October, 2012.
- The use of radios has become increasingly common on PVS pool decks. Radios are used to more effectively conduct meet business including disqualifications, safety incidents, injuries, equipment issues, and other information critical to the operation of the meet.
- The Officials Committee continues to emphasize timely communication with all PVS officials through the monthly Officials Newsletter (which is available on the website) as well as frequent email messages.
