



Administrative Vice Chair's Report PVS House of Delegates Meeting May 2019

Below is a snapshot of 2019 registrations as of May 1. The 2019 numbers will continue to change during the season. Overall athlete registrations increased about 2% from last year. Approximately 7.5% of overall registrations are Flex registrations. Sixteen PVS clubs have made use of the Flex membership category. To date, 234 members have converted from Flex to Premium (~20%).

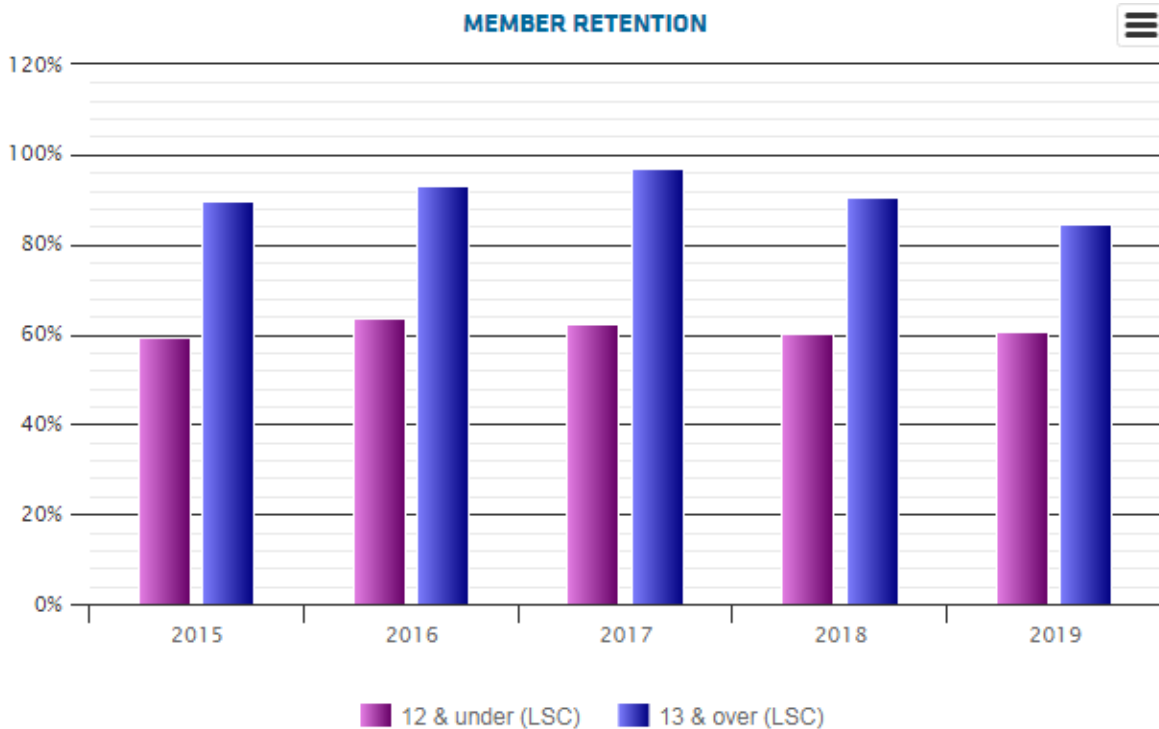

Administrative Vice Chair's Report PVS House of Delegates Meeting May 2019



I am partially through the effort to do a complete overhaul of the PVS Policies & Procedures document. The interim version, posted on the PVS website, has a consistent, legible format and includes all the policy changes since the last update in 2014. A section on the new Minor Athlete Abuse Prevention Policy (MAAPP) has been added. This section will be updated after USA Swimming issues additional information and guidance. The remaining tasks of this effort include removing policies that are no longer relevant and editing policies that need to be updated.

In September 2018, the USA Swimming House of Delegates passed a new LSC Bylaws template. This template cuts the size of the bylaws by nearly two thirds. I will have the PVS Bylaws converted to the new template and submitted to USA Swimming prior to the January 2020 deadline.

I assisted the Competition Committee in developing an online nomination form for the Outstanding Athlete selection. This resulted in more nominations than ever before and multiple nominees in many of the age categories. For the first time in several years, we had an Outstanding Athlete in every age category.

Two years ago, I took over the task of contracting for pools for PVS meets. The biggest challenge this year was finding a pool to host the 12&U LC Championships. The renovated Claude Moore pool in Sterling, VA has agreed to host this meet.

I assisted the PVS Registrar in making sure that new Officials were registered in a timely fashion. I have been assisting clubs in making sure their coaches' registrations and certifications are up-to-date. Although no specific policy has been developed yet, I've made suggestions to meet directors for how they can check coaches' status at their meets.

Per PVS Policy, PVS clubs are required to have a certain number of certified officials based on their number of swimmers. The fine is \$200 per official less than the minimum. The clubs that are not compliant with the minimums will be contacted and invoiced for the fine.

Eleven Potomac Valley-registered athletes have already qualified for the 2020 Olympic Trials.
