## Sanction Update October and Beyond

LSC General Chairs, Sanctions Chairs, Officials Chairs, Times Tabulators, Staff, and Permanent Offices:

The USA Swimming Board of Directors will allow the geographic restrictions on meet sanctions to expire on September 30 at midnight local time. LSCs will no longer be limited to the sanctioning of meets comprised only of athletes and clubs registered within the LSC.

All competition must conform to the LSC Sanction Checklist, the USA Swimming Return to Competition document, carry the COVID language below as well as comply with local, state, and federal public health guidelines.

An LSC shall establish submission deadlines for sanction or approval applications and shall publish such deadlines, along with relevant instructions and forms.

This is not a mandate from USA Swimming to sanction competition, but rather returns authority over the process to the LSCs. It is critical that our LSCs, members, and facilities work together to ensure safe environments in which to hold practice and competition. It is all of our responsibility to stay safe in order to practice and compete. If a meet cannot be held safely, no sanction should be granted.

All competition must conform to local, state, and federal public health guidelines. **Please note the amendments to Articles 202.4 and 202.6 listed below**, originally released in July 2020, as well as reference documents on our COVID Page: (These two documents will be updated by tomorrow's membership communication to reflect the changes for October)
