Greetings from the Chair

We talk about how important it is for you, as an official, to venture out of your own Local Swim Committee (LSC) area to experience officiating through a different lens so you may add some new tools to your officiating toolbelt. This can be done at an LSC meet or at a Speedo Sectionals, Zone, or national-level meet. This spring, we ushered in another great long-course season with some phenomenal national meets: three TYR Pro Swim Series meets and the Toyota National Championships, which served as a selection meet for the 2025 World Championships, 2025 World Junior Championships, and the 2025 FISU Summer World University Games.

At some of these meets, we stretched our wings, practiced the art of flexibility, and learned some different officiating protocols that are more aligned with World Aquatics. All who officiated at these meets took home some new knowledge that may come in handy one day. Just as this does not mean that we are currently adopting World Aquatics protocols across the board, when you officiate outside your LSC where a meet may be conducted a little differently, it does not mean you must change your LSC protocols or the other LSC is incorrect. There is gray in how we dance around a deck to ensure that the rules are being followed and to execute a fair competition. As we approach our summer season, I encourage you all to step out of your comfort zone and officiate at another team's pool, help out your neighboring LSC, spread your wings a little, and enjoy the art of officiating. An unfortunate situation at an Officials Qualifying Meet (OQM) inspired the Colorado Swimming Officials Committee to create the position of "officials coordinator." The officials coordinator's key roles are to help prepare Colorado Swimming officials for evaluations at OQMs, vet officials for national evaluation prerequisites well in advance of OQMs, serve as a mentor for officials who wish to be evaluated or mentored in any position in Colorado Swimming, and to provide evaluators with copies of meet histories and evaluation histories of officials prior to an OQM.

When were goggles first introduced to competitive swimming?

Goggles were first worn by David Wilkie, a Scottish swimmer, in the 1970 Commonwealth Games. David's goggles were homemade and were used, in part, to protect him from a chlorine allergy. Goggles were first allowed in Olympic competition in the 1976 Montreal Olympics. That's right–Mark Spitz swam without goggles when he earned seven gold medals in the 1972 Munich Olympics!

Looking for more details on the Officials' Excellence Award?

The Officials' Excellence Award:

- National recognition for outstanding officials for LSC contribution
- Anyone can submit, although we will ask the LSC Officials' Chair or LSC General Chair for input
- The nominee must be an active member of USA Swimming with current registration
- There are six awards each year, one each in odd-numbered months
- Nominations close around April
- Nominations are held for two cycles (24 months) unless selected
- The National Officials Committee votes in May for the July through next May period (1 cycle)

Hopefully, your LSC OC committee is actively looking for ways to acknowledge officials and appreciate their service at the local level. This award is just a way to further acknowledge those deserving higher
