USA Swimming Safe Sport's Updated MAAPP Requirements

Remember: The deadline to fully implement USA Swimming's updated Minor Athlete Abuse Prevention Policy (MAAPP) is **September 1, 2021**. This is a requirement for all USA Swimming members, its member clubs, LSCs and Zones.

To help all of our members implement this updated policy, USA Swimming has a number of resources available. This includes an editable MAAPP 2.0 document, educational documents to help guide USA Swimming member clubs and hour-long, interactive webinars with time for participants to ask questions.

There are only two educational webinars left!

MAAPP 2.0 Informational Webinars

Corporate Bylaw 2.6.6 Change

Effective September 1, 2021, all employees of USA Swimming, LSCs and member clubs must be non-athlete members of USA Swimming regardless of whether they interact directly and frequently with athletes.

To clarify for our members, employees can be different based on the type of club you are on. This being said, all individuals who are paid or unpaid as part of your clubs staff are considered employees. We are currently seeking clarification from the U.S. Center for SafeSport on this matter, particularly how it extends to our institutionally-owned clubs. We will issue more information once we receive guidance.

- **100% of member clubs in the geographic territory achieve Recognition by September 1, 2021: \$3,000 and \$500 Match-Up coupon code.**

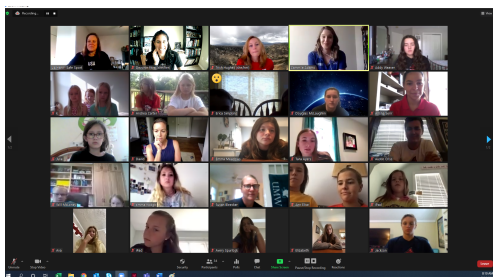

2021 SSRP Trainings

Safe Sport is committed to creating a healthy environment that is free from abuse for all members. As we continue with virtual learning opportunities throughout 2021, we will be increasing security measures to keep parents, athletes and coaches safe during trainings. Starting in January, **all trainings will require individuals to register ahead of time.**

In addition, we have enhanced our Safe Sport Trainings' security measures and will have the following in place:

- Meetings will be locked
- Athlete attendees will only have access to chat with hosts
- Multiple USA Swimming Safe Sport staff will be on all trainings and will monitor participant video share
- Frequent check-ins with attendees
- Screen share and annotation capabilities will be disabled
- Meetings will require registration and athlete training registrations will be cross-checked with USA Swimming member records
- USA Swimming has enabled the At-Risk Meeting Notifier tool from Zoom. This tool searches the public internet for Zoom meeting information and checks the meeting's security settings. Zoom notifies USA Swimming if a meeting appears to be at high risk for being disrupted. This tool is enabled for all USA Swimming hosted Zoom meetings.

SSRP Renewals

- Safe Sport Club Recognition status expires after two years. If you are coming up on your expiration, please start gathering your information. For more information on how to renew, visit [here](#).

Athlete Protection Training (APT)

- All new and current adult USA Swimming members, including adult athletes, are responsible for ensuring compliance with USA Swimming membership requirements. APT must be renewed annually in order to maintain compliance. Adult athlete members will not be permitted to participate in USA Swimming-sanctioned competition if this requirement is not met. Please reference [this](#) document for exemptions and accommodations for APT.

Each Zone has a USA Swimming Zone Safe Sport Chair who assists in the training of and dissemination of information to the LSC Safe Sport Chairs/Coordinators. It is important to know who your Zone Chair is because they will help guide, support and share information with you.
