Clubs are responsible for providing their fair share of timers, and required number of timers will be assigned by the meet director. <u>There will be no electronic timing at this meet; watch times only.</u> Each lane MUST have 3 timers at all times, no exceptions.

Location: Germantown Indoor Swim Center, 18000 Central Park Circle, Boyds, MD 20841 (240) 777-6830

- 10 lane, 25-yard pool, with non-turbulent lane lines and continuous flow-through gutters.
- Water depth is 17' in lane 1 and 6'9" in lane 10 at the starting end and 13'5" at the turning end.
- The competition course has been certified in accordance with current USA Swimming Rules and Regulations, Article 104.2.2(C). The copy of such certification is on file with USA Swimming.
- Manual timing (stopwatches only) will be used for this meet.

Meet Schedule:

- Warm-ups: 8:10 8:50 AM
- Event Start: 9:00 AM

Warm-Up Procedures: The prescribed Potomac Valley Swimming warm-up procedures and safety policies will be followed.

Deck Access: All PVS/USAS registered coaches and deck officials are required to show current 2019 USA Swimming membership credentials on the deck area. Anyone not displaying proper credentials will be asked to leave the deck area. **Parents not working the meet as a deck official, volunteer timer, or other meet position are not permitted on deck.**

Eligibility: This meet is open to invited USA Swimming athletes from the following teams: ASA, FAST, MACH, TIBU, Tollefson, and RMSC. Other interested teams should email the Meet Director for an invitation as space is limited. Swimmers will compete at the age attained on the first day of the meet. It may be necessary to limit entries due to the time constraints.

PVS and host clubs along with their Meet Directors are committed to the <u>Inclusion Policy as adopted by the BOD</u>. Athletes with a disability are welcomed and are asked to provide advance notice of desired accommodations to the Meet Director. The athlete (or the athlete's coach) is also responsible for notifying the session referee of any disability prior to the competition

Rules:

- o Current USA Swimming rules will govern this meet.
- No on-deck USAS registration is permitted.
- All events are timed finals.
- This meet is primarily a pentathlon.
- To enter the "pentathlon competition" a swimmer must be entered and swim all four 25 yard events plus the 100-yard Individual Medley in their age group.
- All other swimmers not entering "pentathlon competition" are limited to 3 events maximum.

No personal chairs allowed on deck for swimmers.

The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision sessions that include 12 &U events per Rule 205.3.1F.

In compliance with USA Swimming Rules and Regulations: the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms or locker rooms. As per PVS policy: the use of equipment capable of taking pictures (i.e. cell phones, cameras) is banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

Deck changes are prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Warning: Any club that enters an unregistered athlete, falsifies an entry in any way, or permits an unregistered coach to represent them, will be fined the sum of \$100.00, and no further entries will be accepted from the club until the said fine is paid. All swimmers, coaches and officials must be properly registered with USA Swimming for 2019.

Entry Information:

- Entry Fees: \$6.50 per individual event.
- Entry Deadline: Monday, December 31, 2018 at 8:00 PM.
- No late entries will be accepted.
- Meet Director will acknowledge receipt by return e-mail within 24 hours. Clubs submitting entries that do NOT receive an acknowledgement should contact the Meet Director by other than e-mail to confirm receipt.

Electronic Entry Procedures:

- Email must include report by name. Include total number of swimmers and total number of events, along with contact information (name, phone number, e-mail) of a club representative in the body of the e-mail.

- Each club is requested to remit one check to cover the entry fees of the entire team. Please do not send cash. Entry Fees are due with entries.

Scoring: The championship scoring will be based on the accumulated times of the five events.

Awards: Special awards will be given for 1st to 3rd place for Overall Pentathlon in 8 year-old girl and boy and 7 & under girl and boy. Ribbons will be given for 1st to 10th place for individual events.

Swim Center Rules and Conduct

At the request of <u>Montgomery County Recreation</u>, swimmers are not to leave the pool deck without appropriate attire. Coaches will be responsible for the conduct of their athletes while in the facility and surrounding grounds. Failure to follow these rules or any inappropriate behavior will result in the athlete being barred from further competition in the meet. Parents will be responsible for the conduct of any minor children that accompany them.

- No glass containers are permitted within the facility.
- Swimmers must be in direct contact with their supervising coach before they will be allowed to enter the pool for warm-up.
- No camera cell phones are permitted in the locker rooms.

Special Note

In granting this sanction it is understood and agreed that USA Swimming, Potomac Valley Swimming, Germantown Indoor Swim Center, Rockville Montgomery Swim Club, and Montgomery County Recreation shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
