Eligibility:	Open to all registered Potomac Valley swimmers 8 years of age and under. All athletes shall compete at the age attained on the first day of the meet.

		No on-deck USAS registration is permitted.			
		The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for the 12 &U sessions in Rule 205.3.1F.			
	Rules:	In compliance with USA Swimming Rules and Regulations, the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms or locker rooms. As per PVS policy, the use of equipment capable of taking pictures (i.e. cell phones, cameras, etc.) is banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.			
		Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.			
		Deck changes are prohibited.			
		Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

Timers:

The Meet sponsor asks each participating club to provide one timer for each 25 entries per session. The sponsoring club will provide 8 timers for the meet.

Deadline:

The Meet Director must receive all entries and payments for this meet no later than 5:00 pm. Tuesday, January 1, 2019.
