No on-deck USA-S registration is permitted.					
<ul> <li>In compliance with USA Swimming Rules and Regulations, the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms, or locker rooms. Per PVS policy, the use of equipment capable of taking pictures (i.e., cell phones, cameras, etc.) is banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.</li> </ul>					
Deck changes are prohibited.					
<ul> <li>Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.</li> </ul>					
<ul> <li>Operation of a drone or any other flying devices is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.</li> </ul>					
No Dive-over starts will be used at this meet.					
<ul> <li>The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for sessions that include 12 &amp; U events per Rule 205.3.1F.</li> </ul>					
Individual Events: Swimmers may participate in only his or her own age group events. Swimmers may enter FOUR (4) events.  To the extent there are available lanes, swimmers can request deck entry at a cost of \$15.00.  *NOTE: The Meet Director reserves the right to rearrange sessions/ start times in order to allow the					
full meet to fit within the pool rental time.					
All Events will be pre-seeded.					
The prescribed PVS warm-up procedures and safety policies will be followed. The Meet Director may determine the structure of warm-up, including times/lane assignments.					
Coaches are responsible for the conduct of their swimmers and families and for cleaning up their team areas.					
Medals will be given for places 1 <sup>st</sup> - 6 <sup>th</sup> and 1 <sup>st</sup> - 3 <sup>rd</sup> for relays.					
Programs will be available for purchase for \$3.00 or via meet mobile.					
Parents not working the meet as a deck official, volunteer timer or other position are not permitted on deck. Only athletes, USA Swimming certified coaches, and deck officials will be permitted on the deck. Coaches and Officials should have proof of active USA Swimming membership with them at all times.					
Each participating club is requested to provide at least one table worker or official (Referee, Starter,
