COVID-19 PROTOCOLS	• Athletes should arrive and depart in their suits. Locker rooms are currently closed but there is a hall bathroom that is open plus three family changing areas.
	<ul> <li>Athletes must shower prior to arrival at the pool. There is also an on-deck shower that can be used.</li> </ul>
	<ul> <li>All attendees (athletes, coaches, officials, volunteers) must wear masks to enter the facility and at all times when inside the facility, with the exception of athletes when warming up, cooling down, and competing. Masks must be affixed to the face without hands and must cover nose and mouth.</li> </ul>
	• All attendees (athletes, coaches, officials, volunteers) are required to fill out the health questionnaire no more than 8 hours before their arrival to the pool and turn it in before entering the facility. All attendees will submit to a temperature check before they are permitted in the facility.
	• Per CDC guidelines, individuals with a body temperature greater than 100.4 degrees will not be permitted entry into the facility.
	<ul> <li>All attendees should maintain a minimum of ten (10) feet distance from all other participants whenever possible.</li> </ul>
	• Each session will be limited to no more than 90 swimmers.
	• Only swimmers, coaches, meet volunteers, and officials will be permitted on the pool deck.
	<ul> <li>During warm-ups, swimmers will wear their masks until they arrive at their lane. They will put it in a plastic zipper bag behind their lane. Once warm-ups are completed, swimmers will immediately put their masks back on.</li> </ul>
	• During competition, swimmers will wear their masks until they arrive at their lane and they will

	take it off put it in their plactic bag, and place it on the chair hebind their starting black
	take it off, put it in their plastic bag, and place it on the chair behind their starting block. Swimmers will immediately put their masks back on at the completion of their swims before they leave the starting area.
•	<ul> <li>Staging for competition will be as follows. Traffic will move in a clockwise rotation:</li> <li>Heat 1 will be at the blocks and will swim</li> <li>Heat 2 will be on the side of the pool behind the diving boards</li> </ul>
	• Heat 3 will be under the mezzanine
•	Swimmers must follow all directions as posted and adhere to all marshal directions.
•	All swimmers must remain in their designated area for their group until they are called for their event and they must return to their area immediately following their event. Most athletes will sit upstairs in the bleacher area with a few select seats on pool level. Seating areas have been marked to ensure social distancing.
•	To access the pool deck from the bleachers, swimmers will go down the stairs on the opposite side of the stands from where they came up and then enter the pool deck through the door on the deep end (turning end) of the pool, underneath the bleachers.
•	To return to the bleachers from the pool deck, swimmers will exit the starting area to their right (clockwise flow). Swimmers will exit the pool deck on the other side of the guard office, below the bleachers, from where they came in, turn left to go to the lobby and then go up the lobby stairs. This ensures one-way traffic flow. (see facility map). There will also be traffic flow signs posted.
•	All swimmers must remain in their designated area for their group until they are called for their event and they must return to their area immediately following their event.
•	Swimmers may not enter another swimmer's "square" of seating.
•	Any swimmer not following the meet protocols will be subject to immediate removal from the meet.
•	All coaches, officials, and volunteers must bring their own water bottle and snacks. Hospitality is not permitted per the facility.
•	We request that all attendees notify the meet director as soon as possible if they have tested positive for COVID-19, shown symptoms or have been in contact with anyone exposed to COVID-19 after attending the meet.
•	No spectators will be permitted. Competition will be live streamed via the Potomac Marlins Facebook page ( <u>https://www.facebook.com/Potomac-Marlins-Swim-Team-116514645119255</u> ).
RULES	Current USA Swimming rules, including the <u>Minor Athlete Abuse Prevention Policy</u> ("MAAPP"), shall govern this meet.
•	No on-deck USA-S registration is permitted.
•	In compliance with USA Swimming Rules and Regulations, the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms, or locker rooms. Per PVS policy, the use of equipment capable of taking pictures (e.g., cell phones, cameras, etc.) is banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods.
•	Deck changes are prohibited.
•	Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
•	Operation of a drone or any other flying devices is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.

EVENT RULES	<ul> <li>Dive-over starts will not be used.</li> <li>The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for sessions that include 12 &amp; U events per Rule 205.3.1F.</li> <li>No deck entries will be accepted.</li> <li>All events are timed finals and will be pre-seeded.</li> </ul>
	<ul> <li>All events will be swum combined gender.</li> <li>Athletes may enter no more than three (3) events per session with a maximum of six (6) events for the meet.</li> </ul>
	<ul> <li>Swimmers may only participate in the sessions with their age group.</li> <li>It is suggested that swimmers not enter back-to-back events.</li> <li>The Meet Director reserves the right to alter the format of the meet after entries are received to best accommodate timelines, space availability and COVID-19 Considerations and COVID-19 Protocols. If the meet is too large to accommodate 3 sessions per day, it will be modified and proven in 4 sessions per day.</li> </ul>
WARM-UP	<ul> <li>swum in 4 sessions per day.</li> <li>The prescribed PVS warm-up procedures and safety policies will be followed.</li> <li>The Meet Director may determine the structure of warm-up, including times/lane assignments.</li> <li>No more than 3 swimmers will be permitted in each warm-up lane.</li> <li>There will be two thirty (30) minute warm-up sessions for each session except the 10&amp;U session which will be 2x25 minutes warm-ups.</li> </ul>
SUPERVISION SEEDING	<ul> <li>Coaches are responsible for the conduct of their swimmers and cleaning up for their team areas.</li> <li>All individual events will be pre-seeded.</li> </ul>
AWARDS PROGRAMS	<ul> <li>There are no awards at this meet.</li> <li>Programs will be available free of charge via Meet Mobile and will be posted to the Potomac Marlins website and emailed out to participating club's coaches.</li> </ul>
CREDENTIALS	<ul> <li>Parents not working the meet as a deck official, volunteer timer or other position are not permitted on deck. Only athletes, USA Swimming certified coaches, and deck officials will be permitted on the deck. Coaches and Officials should always have proof of active USA Swimming membership with them at all times.</li> </ul>
OFFICIALS	<ul> <li>Officials will be identified in advance and coordinated by the Meet Referee, John Kost. <u>MarlinsOfficials@gmail.com</u></li> <li>Officials interested in volunteering should contact the Meet Referee or fill out the <u>Officials</u> <u>Signup</u>.</li> </ul>
	<ul> <li>Officials who have volunteered for this meet should check in at the recording table prior to the start of warm-ups. Certified officials working this meet will need to wear a mask for the duration of the meet.</li> <li>A comprehensive official's briefing will be conducted the night prior to the meet via Zoom.</li> <li>Walk-on officials cannot be accommodated.</li> </ul>
TIMERS	<ul> <li>One timer per lane.</li> <li>Each participating club will be responsible for providing its share of timers.</li> <li>Lane assignments will be made in advance.</li> <li>All timers must always wear a facemask.</li> <li>A comprehensive timers briefing will be conducted the night prior to the meet via Zoom.</li> </ul>

ENTRY PROCEDURES	• Entries shall be submitted by email to the Meet Director, Bill Marlin @ <u>Bill.Marlin@verizon.net</u> .
	• Include in the subject of the email, "PM Easter Egg Meet - ****" with the club's initials in place of the asterisks. If your club submits multiple entry files include training site in the subject of the email.
	• Include in entry email: entry file, report of entries by name, report of entries by event.
	• In the body of your email provide entry numbers (girls, boys, totals), contact information (email, phone, officials contact).
	• Entries directly from individual team members will not be accepted.
	• Entries by phone or fax will not be accepted.
	• The Meet Director will acknowledge receipt by return email within 24 hours. If acknowledgement is not received in a timely manner, please contact the Meet Director.
	• Any club that enters an unregistered or improperly registered athlete, falsifies an entry in any way, or permits an unregistered coach to represent them will be fined the sum of \$100 by PVS and no further entries will be accepted from that club until the said fine is paid.
