Competition will be held in 8 lanes, 25yd. 10 lanes will be used for warm-ups.The pool at Burke Racquet and Swim Club is 25yd x 25m with 11, 25 yard lanes. Competition will be held in 8 lanes, 25yd. 12 Lanes will be used for warm-ups.Water depth range of 4.5’ (lane 1) – 11.8’ (lane 8) at the start and turn ends.Breaks will be scheduled during each session and the competition course will be available for warm-up/cool-down at that time.The competition course has been certified in accordance with current <i>USA Swimming Rules and Regulations</i>, Article 104.2.2C(4). The copy of such certification is on file with USA Swimming.The meet hosts will ensure the required course dimensions.

ELIGIBILITY	<ul style="list-style-type: none"> Open to all registered USA Swimming swimmers 9 years of age and older. No swimmer will be permitted to compete in the meet unless the swimmer is registered as an athlete member of USA Swimming as provided in <i>USA Swimming Rules and Regulations</i>, Article 302.
SWIMMERS WITH A DISABILITY	<ul style="list-style-type: none"> PVS and host clubs along with their meet directors are committed to the Inclusion Policy as adopted by the PVS BOD. Athletes with a disability are welcomed and are asked to provide advance notice of desired accommodations to the Meet Director. The athlete (or athlete's coach) is also responsible for notifying the session referee of any accommodation prior to competition. NECESSARY ACCOMMODATIONS FORM
TIMING SYSTEM	<ul style="list-style-type: none"> Automatic timing (touchpads primary) will be used.
RULES	<ul style="list-style-type: none"> Current USA Swimming rules shall govern this meet. All applicable adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a condition of participation in the conduct of this competition. No on-deck USA Swimming registration is permitted. In compliance with USA Swimming Rules and Regulations, the use of audio or visual recording devices, including a cell phone is not permitted in the changing areas, rest rooms, or locker rooms. Per PVS policy, the use of equipment capable of taking pictures (e.g., cell phones, cameras, etc.) is banned from behind the starting blocks during the entire meet, including warm up, competition and cool down periods. Deck changes are prohibited. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of a backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. Operation of a drone or any other flying devices is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Dive-over starts may be used for events 13& over. The Meet Director and the PVS Technical Committee reserve the right to limit events, heats, swimmers or adjust the format to conform with the 4-hour provision for sessions that include 12 & U events per Rule 205.3.1F.
EVENT RULES	<ul style="list-style-type: none"> Session 1a is only available to invited athletes at the Burke Racquet and Swim Club Swimmers shall compete at the age attained on the first day of the meet. All events will be swum Mixed Gender. A 13&Over athlete may enter a maximum of seven (7) individual events and no more than three (3) individual events per session. A 12&Under athlete may enter a maximum of seven (7) individual events and no more than three (3) individual events per session. All events are timed finals. Distance Events: Entries for the 400 IM, 500 Free, 1000 Free and 1650 Free may be limited to keep manageable timelines. Clubs will be notified if their athletes do not make the cut and will be offered a chance to select an alternate event or receive a refund on the entry for that event. The 1000 Free may be limited to approximately 4 heats – 32 swimmers.

	<ul style="list-style-type: none"> • The 1650 Free may be limited to 3 heats – 24 swimmers. • The 500, 1000, 1650 Free and 400 IM are Positive check in events. <ul style="list-style-type: none"> ○ Friday distance events positive check in closes at 4:30 PM • Swimmers must provide their own timers and counters (if desired) for the 500, 1000, 1650 Free and 400 IM. • Deck entries must be submitted with cash payment no later than 15 minutes prior to the first event of each session. No new heats will be created.
POSITIVE CHECK IN	<ul style="list-style-type: none"> • All events are expected to be pre-seeded, with the exception of the 500 FR, 400 IM, 1000 FR and 1650 FR. • Positive check in may be by Team/Site. Coaches will be given check in sheets. • If timelines require, events 200 yards and longer will be positive check in.
WARM-UP	<ul style="list-style-type: none"> • The prescribed PVS warm-up procedures and safety policies will be followed. The Meet Director will assign warm-ups, including times/lane assignments.
SUPERVISION	<ul style="list-style-type: none"> • Coaches are responsible for the conduct of their swimmers and cleaning up for their team areas.
MEDICAL ASSISTANCE	<ul style="list-style-type: none"> • This facility provides Lifeguard and Pool Operator Supervision, along with an AED.
SEEDING	<ul style="list-style-type: none"> • Fastest to Slowest in all events.
SCORING	<ul style="list-style-type: none"> • This meet is not scored.
AWARDS	<ul style="list-style-type: none"> • There are no awards.
PROGRAMS	<ul style="list-style-type: none"> • Will be emailed to attending teams/sites. No programs will be sold at the meet. Programs will be made available for coaches and officials at the meet, and available on Meet Mobile.
CREDENTIALS	<ul style="list-style-type: none"> • Parents not working the meet as a deck official, volunteer timer or other position are not permitted on deck. Only athletes, USA Swimming certified coaches, and deck officials will be permitted on the deck. Coaches and Officials should have proof of active USA Swimming membership with them at all times.
PUBLICATION OF RESULTS	<ul style="list-style-type: none"> • By entering this meet, participants (and their parents or guardians, if applicable) acknowledge and consent to the posting of official meet results on the Potomac Valley Swimming (PVS) website. Athlete birthdates will not be included in any posted results. Meet results may be accessed by third-party organizations or applications that use publicly available swimming data for purposes such as rankings, recruitment, or goal tracking
SPECTATOR ENTRY FEE	<ul style="list-style-type: none"> • Limited spectator seating is available.
OFFICIALS	<ul style="list-style-type: none"> • Each participating club is requested to provide at least one table worker or official (Referee Starter, Chief Judge or Stroke & Turn Judge) per session if entering 25 or more splashes. • Officials interested in volunteering should complete the online form HERE: OFFICIALS SIGN UP LINK • Officials volunteering for this meet should sign in at the recording table prior to the start of warm-ups. Certified officials who have not previously volunteered should contact the referee upon arrival to make their services available. A comprehensive officials briefing will precede each session during warm-ups.
TIMERS	<ul style="list-style-type: none"> • VOLUNTEER ASSIGNMENTS WILL BE MADE BASED ON PROPORTION OF ENTRIES. The Signup Genius will be emailed to teams in advance.
ENTRY PROCEDURES	<ul style="list-style-type: none"> • Entries should be submitted by email to the ENTRY COORDINATOR. • Include in the subject of the email, "2026 NCAP Winter Qualifier - *****" with the club's initials in place of the asterisks. If your club submits multiple entry files, include the training site in the subject of the email. • Included in entry email: entry file, report of entries by name, report of entries by event. • In the body of your email provide entry numbers (girls, boys, totals), contact information (email, phone, official contact). • Entries directly from individual team members will not be accepted.

- Entries by phone or fax will not be accepted.
- The Entry Coordinator will acknowledge receipt by return email within 24 hours. If acknowledgement is not received in a timely manner, please contact the Meet Director.
- Any club that enters an unregistered or improperly registered athlete, falsifies an entry in any way, or permits an unregistered coach to represent them will be fined the sum of \$100 by PVS and no further entries will be accepted from that club until the said fine is paid.
